Warranty

Diadem warrants that the Selected Systems will be free from defects in materials and workmanship for a period of one (1) year from the date of shipment. If the product proves defective during the warranty period, Diadem, at its option will:

- (1) repair the product by means of telephone support or depot service at no charge for parts (some labor charges may apply)
- (2) replace the product with a comparable product which may be new or refurbished or used Diadem recommends the Customer first utilize support materials shipped with the product, product diagnostics, information contained on the Web, and email support. If unsuccessful, to obtain service under this warranty the Customer must notify Diadem Telephone Support or its authorized service representative of the defect before the expiration of the warranty period. Customers will provide appropriate assistance to Telephone Support personnel to resolve issues.

If telephone support is unsuccessful, Diadem or its authorized service representative will instruct the customer on how to receive warranty repair as provided below:

- (1) Service is available in the United States
- (2) Outside the US, Canada, & EEA, service is available in the country of purchase

Diadem reserves the right to charge for service in exception cases.

A description of the depot process may be obtained from the local Diadem Customer Support Center or authorized Diadem affiliate/reseller/distributor. Depot service is at Diadem or its authorized service representative's sole discretion and is considered an option of last resort.

If the Customer's product contains features that enable Diadem or its authorized service representative to diagnose and repair problems with the product remotely, Diadem may request that the Customer allow such remote access to the product.

In the maintenance of the product, Diadem may use new or equivalent to new parts, assemblies or products for equal or improved quality. All defective parts, assemblies, and products become the property of Diadem. Diadem may require the return of parts, assemblies and products to a designated Diadem or the Diadem representative from which the part, assembly, or product was originally purchased.
